**RENT:** Boat - \$85, Camper - \$85, Golf Carts - \$25. Other items will be rented on a case by case basis, with approval by the Michigan Park Board and/or Michigan Duffer's Club. **Rental amount will be due prior to items being removed from building.**

**LIABILITY INSURANCE:** The North Dakota Insurance Reserve Fund (our insurance carrier) requires the party renting the facility to sign a form releasing the Michigan City Park Board and Duffer's Club from liability. This form is attached and made part of this agreement.

**GUIDELINES:**

- The building is smoke-free, which includes the outside area within 20 feet of the building.
- Assignment of the rental area or subletting to another party is not allowed.
- The facility will be clean and ready for use. The facility is to be left in the condition it is found.
